**Item 9: Other Events**

Aboitiz Land, Inc. (AboitizLand), signed today the Share Purchase Agreement (SPA) with Alsons Land Corporation (ALC) for the acquisition of ALC's 60% interest in Lima Land Inc. for a purchase price of One Billion Three Hundred Sixty Four Million Three Hundred Twenty One Thousand Nine Hundred Pesos (P1,364,321,900.00). The purchase price includes LLI's interests in its wholly-owned subsidiaries, Lima Utilities Corporation and Lima Water Corporation. The buyout is expected to close no later than thirty (30) days after the execution of the SPA.


LLI is the owner and operator of LiMA Technology Center, a PEZA registered industrial park located in Batangas. On the other hand, AboitizLand, the real estate arm of the Aboitiz group, is the developer and operator of two economic zones, the Mactan Economic Zone II in Barangay Mactan, Lapu Lapu City, and the West Cebu Industrial Park in Balamban, Cebu, through its subsidiary, Cebu Industrial Park Developers, Inc.
