Item 9: Other Events

Aboitiz Equity Ventures, Inc. (AEV) completed the divestment of its interests in the shipping and shipping related businesses with the disposition of all its interests in Aboitiz Jebsen Company, Inc., Aboitiz Jebsen Manpower Solutions, Inc., and Jebsens Maritime, Inc. (collectively the "Abojeb Group") to PTC Holdings Corporation, Behike Holdings, Inc., Valdicava Holdings, Inc., Jebsen Invest A.S. and Furunes Holdings Inc.

The total purchase price of AEV's interest in the Abojeb Group is equivalent to USD 8.3 million. The purchase price includes Abojeb Group's interest in its subsidiaries, including among others, Starbulk Aboitiz Jebsen Crew Management Philippines, Inc., Filscan Shipping, Inc., General Charterer Ocean Shipping, Inc., Selandia Crew Management, Olympic Jebsen Offshore, Inc., and Viking International Carriers, Inc., all of whom are engaged in recruitment, ship manning and related businesses.


The divestment of interest in the Abojeb Group is part of AEV's strategy to focus on its identified core businesses such as power generation and distribution, financial services, food and real estate and infrastructure. Jebsen Invest AS, AEV's long-time partner in the Abojeb Group, will continue to partner with Aboitiz family members in their personal capacity.
