(AEV) was informed by Union Bank of the Philippines (UnionBank) that it received today, the approval from the Monetary Board of the Bangko Sentral ng Pilipinas (BSP), on UnionBank's offer to acquire 194,371 common shares of City Savings Bank, Inc. (CitySavings) from AEV and its subsidiary, Pilmico Foods Corporation.

Accordingly, the parties signed today the Deeds of Absolute Sale setting forth the final terms and conditions of the sale of the CitySavings shares, including the total purchase price thereof which is at Php5,728,099,764.03.
