

Item 9 : Other Events

Aboitiz Equity Ventures, Inc. (AEV) received today the approval of The Philippine Dealing and Exchange Corporation (PDEX) for the listing of its five-year and three-month, seven-year, and twelve-year bonds effective on August 6, 2015 (the "Bonds").


The PDEX approval paves the way for the secondary market trading of the Bonds. The five-year and three-month bonds, with a fixed interest rate of 4.4722% per annum will mature on 2020, the seven-year bonds with a fixed interest rate of 5.0056% will mature on 2022, and the twelve-year bonds with a fixed interest rate of 6.0169% per annum will mature on 2027.
